On January 15, 2018, Charles A. Baker notified Regeneron Pharmaceuticals, Inc. ("Regeneron" or the "Company") of his intention not to stand for reelection as a member of the board of directors of the Company (the "Board") when his current term expires and to retire from his position as a member of the Board effective as of the conclusion of the 2018 annual meeting of shareholders of the Company (expected to be held on June 8, 2018). Mr. Baker, 85, joined the Board as its second non-employee member and is retiring after 29 years of service. Mr. Baker's decision not to stand for re-election was not due to any disagreement with the Company on any matter relating to Regeneron's operations, policies or practices.
